#### **1. Registration**

To qualify for the Fly 'n Buy™ benefits prospective purchasers must advise CEI by e-mail or fax **before booking** airfares that they intend traveling to Plettenberg Bay to consider buying property. A CEI Plett Estate Agent will request a few personal details to complete the registration.

#### **2. Purchase Price Qualification**

The customer must purchase a conventional title or sectional title property (vacant stand, house, small holding or apartment) through CEI Plett, within the municipal boundary of Plettenberg Bay (including Natures Valley), for a value exceeding R750 000 (Seven hundred and fifty thousand Rand).

#### **3. Airfares**

#### **4. Accommodation**
